The meeting was chaired by Shri P. S. Jahari, ACS, Principal Secretary, NCHAC. Smt. Rebecca Changsan, ACS, Joint Secretary assisted him in the meeting. After welcoming the members the Principal Secretary informed that the meeting would basically discuss review on progress of different departmental schemes by Hon'ble Governor of Assam for Dima Hasao as well as other progresses.. 4	PWD (R&B)	<ul style="list-style-type: none"> <li>The Addl.Chief Engineer has informed that 2 (two) MOS projects are yet to be completed.</li> <li>A total of 7 (seven) flagship projects is going on in Haflong and 3 (three) in Maibang.</li> <li>One DHATC project is not completed.</li> </ul>
5	P.H.E	<ul style="list-style-type: none"> <li>The Principal Secretary was pleased to know that Dima Hasao came under Top 10 with 86% at FHTC Program under JJM</li> <li>HGJ certification in Maibang need to be improved.</li> <li>SDLL Umrangso need to improve the percentage of water quality tests.</li> <li>Schools/ AWC running water facility need to be improved.</li> </ul>
6	Food & Supplies	<ul style="list-style-type: none"> <li>The Dy. Director has informed us that Total Nos.of active Lamps is 20Nos.</li> <li>The e- POSE distribution status is good</li> <li>Total Nos.of active FPS is 207 Nos.</li> </ul>
7	Fishery	<ul style="list-style-type: none"> <li>The Fishery Development Officer has informed that the physical and Financial Progress under PMMSY is good</li> <li>Physical Progress of projects of current year is good.</li> </ul>

8	Soil Conservation	<ul style="list-style-type: none"> <li>The Addl. Director, Soil informed that the progress of various schemes /project undertaken by them during the financial year 2024-25,like afforestation, Agar plantation, Horticulture plantation,BenchTerracing,Farm pond etc.</li> <li>They also informed the house regarding the water harvesting pond at Miyungkro.</li> <li>Staggered Trenches at ChotoMuolkpi,Boulder revetment at Miyungkro,Water harvesting structure at Jatinga,Goatery at BoroMuolkoi&amp; Piggery at Kapurchera,Water harvesting tank at BoroMoulkoi,Arecanut plantation at Miyungkro,Two days training for SHG at BoroMuolkoi,Sapling distribution at Harangajaoetc.etc.</li> </ul>
9	Water Resources	<ul style="list-style-type: none"> <li>The Addl. Chief Engineer has given report on erosion caused and anti- erosion measures taken under RIDF XXIX.</li> <li>On being asked about the water bodies in Maibong, the engineer told about the Mahur river, which is mainly used.</li> </ul>
10	Irrigation	<ul style="list-style-type: none"> <li>The Addl. Chief Engineer has informed that no flagship programs are entrusted to them yet.</li> <li>The Jt. Secretary asked them about the NLCPR scheme and as to when the payment will be done and the work completed.</li> </ul>
11	HEALTH	<ul style="list-style-type: none"> <li>The JDHS informed the house about the percentage of infants immunization, Percentage of pregnant mothers immunized against the target, Percentage of deaths in the district etc.etc.</li> <li>They placed the 40 indicators with weightage.</li> </ul>
12	Co- Operative Societies	<ul style="list-style-type: none"> <li>The District Deputy Registrar, Co-Operative Societies informed about Amrit Sarovar in Hatikali Lamps is under progress.</li> <li>Computerization of Lamps is done where Lamps have to enter their transactions daily in the portal.It is a continuous process.</li> </ul>
13	EDUCATION	<ul style="list-style-type: none"> <li>Since Education Department is given grave interest many Schemes under the Govt.was discussed and the Department was asked to complete the task as soon as possible within the given time.</li> <li>The Jt.Secretary (Education) has precisely put pressure on this.</li> </ul>
14	Industries & Commerce	<ul style="list-style-type: none"> <li>The Addl. Director has informed that the PMEGP Scheme 28 applications with bank is pending.</li> <li>PMFME scheme 54 is pending.</li> <li>Pm Vishwakarma Scheme 3<sup>rd</sup> stage clearance 28</li> </ul>

Lastly, the Principal Secretary and Secretary,NCHAC,Haflong observed the PPTs of all the departments very minutely and given suggestion to them for further improvement etc.The Principal Secretary also directed to the departments to take early necessary steps to achieve 100% of the target of flagship programmes within the end of this Financial year 2024-25.
